MEETING NOTES:

The PVM HOA Board of Directors (BOD) met the Falcon Fire Station #3, 7030 Old Meridian Road, Falcon with the following agenda items discussed:

REPORTS OF OFFICERS, BOARDS & COMMITTEES:

- 1. Treasurer Report; the *Cash Flow Statement* and *Budget Sheet* as of January 31, 2019 was distributed, discussed, and approved. To date twenty-eight (28) of the sixty-three (63) HOA Assessment/Dues have been received. *Friday, March 1st*, 2019 is the deadline.
- 2. The ACC Director reported that there were no new construction requests.
- 3. President Allender reported that he will be out of town until the end of March and will forward his incoming email to another board member.

UNFINISHED / OLD BUSINESS:

- 1. 2019 Election As of today, twenty-five (25) ballots have been received from community members for the 2019 Board of Directors Election. All ballots must be received by the HOA Board by Midnight MST, February 28, 2019. The number of responses needed to meet the HOA's current quorum requirement is 51% of the 63 lot owners, or 33 total responses. The nomination committee will count and record the ballots; reporting the results at the March 4th Board Meeting.
- 2. Update on Road Repairs President Allender reported that the El Paso County DOT has been in contact with him and in addition to assigning an official work order number; they anticipate starting on the project in the very near future. Much depends on finishing up with a current job and weather conditions.

- 3. Fire water storage and agreement with Peyton Fire District President Allender reported he has been in contact with both Falcon and Peyton Fire Departments. At our request, an on-site meeting/inspection of the PVM's 30,000 gallon water storage tank did take place with Jeff Peterson of the Falcon Fire Department and recommendations were made on how to proceed with ensuring the tank meets current code requirements. The board was advised to see if the original PVM developer has information regarding whether the current tank is metal or fiberglass (with a metal tank preferred) and possibly obtaining any other specifications on record. The board will follow up and report back.
- 4. Status of updated Rules and Regulations –the Board met on January 23, 2019 and will meet again February 13th to continue with this project.
- 5. The Outlook email address changeover for board members and officers remains in transition.

NEW BUSINESS: (NO NEW ITEMS)

ITEMS FROM COMMUNITY MEMBERS:

- 1. Thanksgiving weekend shooting activity Nothing new reported back from the El Paso County authorities.
- 2. Potential *Neighborhood Watch* Dru Dukart, Secretary, will reach out to the El Paso County Sheriff's Department for more information with hopes of scheduling a presentation for the community during an open board meeting.

The next PVM HOA Board of Directors meeting will be held on Monday, March 4, 2019 from 6-8 PM, at the Falcon Fire Station One.
